

RELEASE OF LIABILITY, WAIVER OF CLAIMS, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

For and in consideration of being permitted by the Land Executive to pursue the Activity in/on the Property, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, I hereby agree that I, my heirs, legal representatives and assigns will not make a claim against, sue, or prosecute either Land Executive or WikiParx for injury or damage resulting from the negligence or other acts, howsoever caused, by any employee, agent or contractor of either the Land Executive or WikiParx as result of me pursuing the Activity. In addition, I hereby release and discharge the Land Executive and WikiParx from all actions, claims or demands that I, my heirs, legal representatives or assigns now have or may hereafter have for injury or damage resulting from me pursuing the Activity.
